Ladies and Gentlemen:

### 1. Subscription.

(a) The undersigned ("Subscriber") hereby subscribes for and agrees to purchase the Non-Voting Series A Preferred Stock (the "Securities"), of BOXABL Inc., a Nevada corporation (the "Company"), at a purchase price of \$0.80 per share (the "Per Security Price"), offered by the Company's selling securityholder upon the terms and conditions set forth herein. (c) **Joinder to Stockholders Agreement.** By subscribing to the Offering and executing this Subscription Agreement, Subscriber (and, if Subscriber is purchasing the Securities subscribed for hereby in a fiduciary capacity, the person or persons for whom Investor is so purchasing) hereby joins as a party that is designated as a "Stockholder" under the Fourth Amended and Restated Stockholders Agreement, in substantially the form attached hereto as **Exhibit A** (the "Stockholders Agreement").
